INSECT AND DISEASE MANAGED CARE, fertilizing, special soil treatments, pruning, tree, shrub and stump removal, cabling, bracing, special tree and/or shrub planting and transplanting, plus many other types of tree and shrub care which only a professional should service.

Branch Tree & Landscape Service follows ISA Standards and the latest methods suggested by current arboricultural research when doing cabling, bracing, bark wound tracing, pruning, and removal of grinding roots.

PROFESSIONAL TREE STANDARD TERMS

Pruning/Crown Cleaning: Thinning and removal of dead, diseased, damaged, broken, stub and interfering limbs, retaining actual crown as set forth by industry standards.

Hazard Pruning: Removal of dead, diseased or weak branches. Hazardous pruning shall consist of the removal of the described branches to a size that in falling would injure a person. (Usually consist of 2" or more in diameter.)

Thinning: Selective removal of individual branches to help reduce weight stress. wind resistance and allow for more needed or required sunlight in many incidences.

Crown Reduction or Heading Back: Reduction of overall height and/or width (usually for fruit and ornamental trees and evergreens.)

Elevation: Pruning or removal of required limbs for greater height and clearance over lawn, driveway, sidewalks, and other structural items.

Clearance: Pruning or removal of required limbs as outlined to provide proper distance to building, lights, wires, plants or other items that may be requested or suggested by the client or ourselves.

Note:

1. Any alterations to the written quote involving additional work or services which were not identified at time of estimate, will be provided at an extra charge. (i.e. cement in tree, wasp or bee nest, etc.) All agreements are contingent upon strikes, accidents, weather or delays in which we cannot control
2. Client releases and holds harmless, Branch Tree & Landscape Service, Inc. of all liability for areas where trucks and/or equipment must be used or cross driveways, sidewalks, or patios for access to work area.
3. Branch Tree & Landscape Inc. is not responsible for underground wiring, sprinklers or septic systems unless otherwise noted.
4. A 20% handling fee will be in effect for all work canceled.
5. This proposal is valid for 30 days without subject to change or cancellation.

All tree and shrub plantings carry a limited warranty for one year with one replacement. Warranty excludes drought, damages, flooding lack of normal care, or act of God. There is not written, verbal or implied warranty for transplanting services.

In the event of default of payment in full by purchaser of services or product, Branch Tree & Landscape Service, Inc. reserves the right to enforce payment in full through legal proceedings. Full payment will also include fees for processing, issuance and services of process, all court costs and reasonable legal fees in connection with recovery of outstanding debt. Client further agrees to pay late accumulating interest at 1.5% interest monthly
